The roles and Responsibilities of the Position would include but not limited to;

- Educate on high quality comprehensive testing for relevant biomarkers in precision oncology and make ties to Lilly pipeline assets.

### **Basic Qualifications**

- Advanced doctoral degree is preferred (e.g. PharmD, MD, DO, or PhD). Candidates with a diagnostic laboratory and or clinical pathology background (e.g. MSN, PA) and hematology/oncology experience will also be considered.
